Statement of Commitment to Child Safety

Fountain Gate Secondary College seeks to ensure all students are safe and personally grow in their academic and social learning.

Fountain Gate Secondary College is committed to ensuring that every child feels safe in our school environment and the College has an absolute zero tolerance to any form of child abuse.

What is child abuse? Child abuse includes:

- Sexual or grooming offences
- Physical violence
- Serious emotions or psychological harm
- Serious neglect

Fountain Gate Secondary College has legal and moral obligations to contact authorities which we are worried about a child's safety, which we follow rigorously. All allegations and safety concerns will be treated very seriously and consistently in line with our child safety policies and procedures.

Fountain Gate Secondary College fully support the Child Safety Standards through a variety of programs including the Wellbeing Team, Home Groups and our program for supporting students with a disability. We are committed to the safety of children from a culturally and/or linguistically diverse background, and to providing a safe environment for children with a disability. Elements of Child Safety are also covered in our Health curriculum and reflected in our screening and recruitment practices for all staff and volunteers.

Fountain Gate Secondary College has specific policies, procedures and training in place that supports our leadership team, staff and volunteers to achieve these commitments. Fountain Gate Secondary College is committed to regularly training and educating our staff and volunteers on child abuse risks. We are committed to preventing child abuse and identifying risks early, and removing and reducing these risks. The child safety standards are referenced in our school policy, 'Mandatory Reporting'.
